1. <b>EQUIPMENT:</b> Armatrak hereby Rents to Renter the following equipment:
- 30' Gooseneck Trailer \$220/day \$980/week
- 20' Tilt Deck Car Hauler \$120/day \$660/week
- 18' Equipment Trailer \$120/day \$660/week
- 16' Deck Over Trailer \$100/day \$540/week
- 10' Utility Trailer \$80/day \$450/week
- Winch \$25 per rental
2. <b>RENTAL TERM:</b> The Rental will start on $\frac{\frac{1}{2024}}{\frac{1}{2024}}$ (begin date) and will end on $\frac{\frac{1}{2024}}{\frac{1}{2024}}$ (end date) (Rental Term). How many days?
3. <b>LEASE PAYMENTS:</b> Lessee agrees to pay to Armatrak as rent for the Equipment the amount of

comes back without any damage. Renter has the option to fix or replace the damage and will be refunded based on post inspection.
4. POSSESSION AND SURRENDER OF EQUIPMENT: Renter shall be entitled to possession of the

- 4. **POSSESSION AND SURRENDER OF EQUIPMENT:** Renter shall be entitled to possession of the Equipment on the first day of the Rental Term. At the expiration of the Rental Term, Renter shall surrender the Equipment to Company by delivering the Equipment to Company or Companies agent in good condition and working order, ordinary wear and tear excepted, as it was at the commenc ement of the Agreement.
- 5. **USE OF EQUIPMENT:** Renter shall only use the Equipment in a careful and proper manner and will comply with all laws, rules, ordinances, statutes and orders regarding the use, maintenance and handling of the Equipment.
- 6. **CONDITION OF EQUIPMENT AND REPAIR:** Renters or Renters agent has inspected the Equipment and acknowledges that the Equipment is in good and acceptable condition.
- 7. MAINTENANCE, DAMAGE AND LOSS: Renter will, at Renter's sole expense, keep and maintain the Equipment clean and in good working order and repair during the Rental Term. In the event the Equipment is lost or damaged beyond repair, Renter shall pay to company the replacement cost of the Equipment; in addition, the obligations of this Agreement shall continue in full force and effect through the Rental Term.
- 8. **INSURANCE:** Renter shall be responsible to maintain insurance on the Equipment with losses payable to Company against fire, theft, collision, and other such risks as are appropriate and specified by Company. Upon request by Company, Renter shall provide proof of such insurance.
- 9. **COMPANIES REPRESENTATIONS:** Armatrak represents and warrants that he/she has the right to Rent the Equipment as provided in this Agreement and that Renter shall be entitled to quietly hold and possess the Equipment, and Armatrak will not interfere with that right as long as Renter pays the Rent in a timely manner and performs all other obligations under this Agreement.
- ${\bf 10.}\ \textbf{OWNERSHIP:}\ \textbf{The Equipment is and shall remain the exclusive property of Armatrak Ltd.}$
- 11. LATE CHARGES: If any amount under this Agreement is more than 1 day late, Lessee agrees to pay a late fee of 50% of the daily rate.
- 12. **Notice:** The renter also agrees to immediately inform the Company if the Equipment is in an accident or incident of any kind.
- 13. Wash: The renter also agrees to bring the trailer back as clean as when they picked it up.
